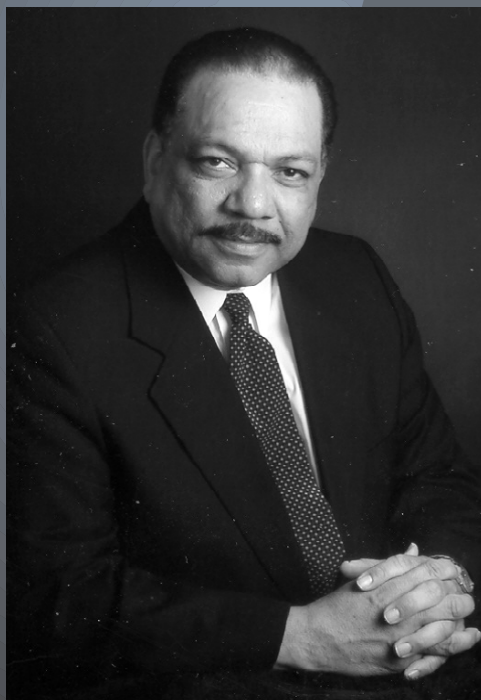

BIOGRAPHY

I am married to Donna Camille and together we have three grown sons: Joseph, Benjamin, and Marc, ten lovely grandchildren, and one stubborn Beagle named Amanda. I graduated from Wayne State University in 1965 with a Bachelor's Degree in Art Education. I taught in the Detroit school system for twenty-eight years.

From April 1975 to December 2000 I was the senior minister of two churches in the city of Detroit: *Zion Congregational Church of God in Christ* (1975-1982), the second oldest Pentecostal church in Michigan, and *Maranatha Christian Church* (1982-2000), an Evangelical/Charismatic church.

In March of 1998, while reading the apostolic fathers and subsequent church history in preparation for a Wednesday evening bible study, I discovered the Church to be charismatic/liturgical, hierarchical, and Eucharistic-centered. In light of that discovery, Donna and I began a two-year journey into the Catholic Church that culminated in fifty-four members of my previous congregation, including fourteen members of my family, entering the Catholic Church. We entered R.C.I.A. at St. Suzanne Catholic Community on September 10, 2000, and were welcomed into the Catholic Church through confirmation during Easter Vigil on April 14, 2001.

I was ordained a Permanent Deacon in the Archdiocese of Detroit on October 1, 2005. I received my Masters in Pastoral Studies from Sacred Heart Major Seminary on April 28, 2007, and on May 31, 2007 I retired from the position of evangelization coordinator for the Archdiocese of Detroit. As deacon I serve at the pleasure of Archbishop Allen Vigneron at St. Suzanne/OLGH Catholic Community, where Fr. Richard Lewneau is the pastor.

ENGAGEMENT AGREEMENT FOR ALEX JONES

Thank you for inviting me to come and share at your event. It is my sincere desire to come and make a positive contribution to your group with an uplifting message of God's grace and love. Below is an agreement that will help us coordinate our efforts so that you will know my needs and I will meet your expectations. If you need more information, please feel free to call or email me so that we can work out any over looked details.

Holding Dates: Because of the numerous inquiries I receive, and my desire to serve the People of God, I do not hold dates. If the Letter of Agreement is not returned in two weeks, this (these) date(s) will be considered open.

Cancellation: If the event organizer cancels this agreement, the following schedule of percent of deposit will be in effect from the time written notification or phone call is received.

30 days or less before engagement	100%
31 – 60 days	75%
60 – 90 days	25%

If cancellation/postponement is unavoidable, please verify the cancellation by telephone, followed by a written letter within five days. Sometimes canceling an event is unavoidable. If I have to cancel speaking at an event, you will be sent a full refund for the amount of your check submitted with the Letter of Agreement.

Recording I encourage professional audio and videotaping of my presentations. I ask:

- 1) a professional taping technician do the recording
- 2) I receive the master copy within 30 days of the session
- 3) 10% of all revenue from recordings (tape/CD) be forwarded to me

Standard Presentation: If the presentation is to take place in a church setting, I can speak from the ambo or from a lectern placed on the floor in front of the altar. A wireless lapel microphone is preferred. If the event is in a conference setting, I can speak from a podium with a standing microphone.

Room Setup for Workshops: If my presentation is in PowerPoint, a LCD projector, a large projection screen, extension cords, and a small table for the projector must be provided. A lapel microphone is preferable to a standing or held-held mike.
